On 12/10/19, an accident occurred on South Clary Road in Jefferson involving David P. Vallance, 69, of Jefferson. Mr. Vallance was operating his 2017 Dodge Grand Caravan southbound when a deer entered the roadway from the right side and was struck. Deputy Jonathan Colby was the investigating officer.
